The French Government will host the 21st Conference of the Parties (COP 21) of the United Nations Framework Convention on Climate Change (UNFCCC) in Paris. As part of this process, the French Government is pursuing a broad approach to not only arrive at a political agreement, but also facilitate the development of mitigation contributions by public and private entities. These contributions will articulate specific actions, which taken together will form a Solution Agenda that will help the global community avoid dangerous climate change and transition to a low-carbon economy.

The WBCSD is leading the private sector led contribution through the Low Carbon Technology Partnership initiative (LCTPi). The LCTPi is structured across key industry sectors, including agriculture and forests.

The LCTPi for agriculture is focused on Climate Smart Agriculture and is led by major global agribusinesses.

The overall ambition of the WBCSD CSA LCTPi towards 2030 is to produce 50% more available food and strengthen the climate resilience of farming communities whilst reducing agricultural and land-use change emissions from commercial agriculture by at least 3.7 Gt CO2 eq/yr by 2030 (50%). By 2050 the target is to achieve a 65% emissions reduction.

The session will cover the work of the group to date and the findings of the West African Regional Dialogue.

The session is convened by the WBCSD Climate Smart Agriculture members chaired by Olam, PepsiCo, Monsanto and the Kellogg company in partnership with CCAFS and other leading NGOs.

The session is aimed at organisations in the agricultural value chain that have interests in West Africa and are seeking to scale up and collaborate on potential Climate Smart Agricultural solutions.
